**ELIGIBLE BREEDS AND REGISTRY**

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzois, Cimechi dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Silken Windhounds, Sloughis, and Whippets may be entered in the regular stakes.

Limited breeds may be entered in the Limited Stake or the Singles Stake.

Limited stake breeds currently include: purebred Chart Polskis, Galgo Españols, Magyar Agars, Peruvian Inca Orchids, & Portuguese Podengos (Medio, Grande & Pequeno) and must be individually registered with the appropriate registry.

All entries shall be individually registered with the AKC (ILP/PAL included), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS.

**NOTICE FOR FIRST-TIME ENTERED HOUNDS**

**As of January 1, 2003, any hound which is first-time entered in a trial, must have a copy of the hound's registration papers to send in with the entry. This is true if the hound is entering Open, Veteran, Singles, or Limited Stake for the first time. This is waived for hounds registered with the NGA.**

**REGULAR STAKES OFFERED**

**OPEN STAKE:** Any eligible Sighthound that has met certification requirements excluding ASFA Field Champions of record.

**FIELD CHAMPION STAKE:** Any ASFA Field Champion.

**VETERAN STAKE:** Any eligible Sighthound that has met certification requirements and is 6 years of age or older (5 years for Irish Wolfhounds; 7 years for Afghans, Saluki, Rhodesian Ridgebacks, and Whippets).

**SINGLES STAKE:** Any eligible Sighthound including those disqualified to run in other stakes. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake. Limited breeds are not eligible for these titles. Each hound runs alone.

**LIMITED STAKE:** Any eligible Sighthound of a Limited breed that has met certification requirements. Not eligible to compete in Best of Breed or Best in Field.

**BEST IN FIELD WILL BE OFFERED BOTH DAYS**

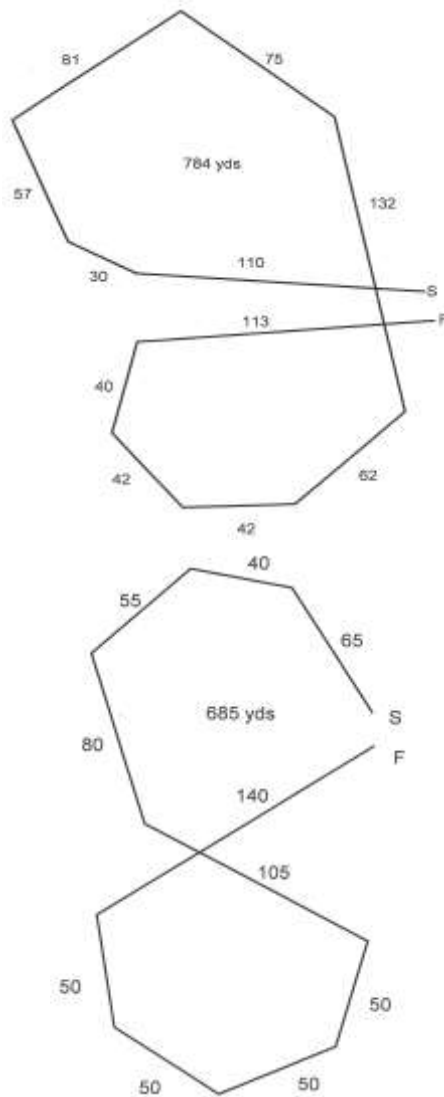
**CONDITIONS OF ENTRY**

- All entries must be one year or older on the day of the trial.
- Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more.
- Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call.
- Exhibitors are requested not to bring bitches known to be in season to the field
- Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered.
- Hounds with breed disqualifications are not eligible to enter except in the Single Stake.
- Hounds not present at the time of roll call will be scratched.
- All hounds will run twice, in trios if possible or braces (except in the Single Stake), unless excused, dismissed or disqualified. The members of the Coursing Hounds Association of the Mid-Potomac reserve the right to alter the course plan as required by weather and/or field conditions on the day of the trial.

**ENTRIES will not be acknowledged by mail. Separate, dated entry forms are required for each day.**

**Lunch will be available both days for a donation.**

**COURSE PLANS** -field is next to main road into Oatlands  
**Sat. – 784 yds. Sun. – 685 yds.**



Course plan each day will be reversed for final run.

Equipment: lure machine is battery-powered continuous loop.

Lure type: highly-visible white plastic bags.

The club reserves the right to alter the course diagram as required by weather and/or field conditions on the day of the trial.

**DIRECTIONS TO THE FIELD:**

**Directions from the North:**

From Interstate 70 in Frederick, MD: take Route 340/15 South. Bear onto 15S at the split. Leesburg is 24 miles. Follow 15/7 Leesburg bypass to 15 South. Oatlands is 6 miles south of Leesburg on Rt. 15. Turn LEFT on to Gap Road and proceed to the field on the right. Gap Rd. is BEFORE Oatlands. Watch for coursing signs.

From Washington Beltway: take either Route 7 or Dulles Greenway west to Leesburg 15/7 bypass, then exit south on Route 15-South. Follow rest of directions above.

**Directions from the South:**

Follow Route 15 North toward Leesburg. Oatlands is on the right before Leesburg. Go past the main entrance of Oatlands and TURN RIGHT on the first road, Gap Road. This is a narrow dirt road. Follow coursing signs to the field.

**FIELD:**

The field is horse-board fenced & is next to main road into the plantation. Please bring our own shade and water.

**\*\* Limited CAMPING (5 vehicles) on the field is permitted w/prior notification to Trial Chair, Jay Johnson – 540-349-8272 h. \*\***

**CERTIFICATIONS:**

Certification will be offered on Saturday after completion of the trial if weather, equipment, daylight, and judges permit. The cost is \$10.00 per hound. Hound certification will NOT be offered on Sunday.

**PRACTICE:**

Practice will be offered on Saturday ONLY AFTER CERTIFICATIONS, weather, equipment, and time permitting. Cost is \$3.00 per hound.

**DISCLAIMER:** Upon entering this trial, the exhibitor agrees to hold harmless the CHAMP club, its members, and the event location organization for any injury, loss, or damage sustained by person or hound. There will be no refund in the event that the trial has to be canceled due to weather or other unforeseen circumstance.

## ATTENTION SALUKIS

### Special Trophies and Awards for Salukis

In conjunction with CHAMP's trials on 11 & 12 November 2017, the ASA (American Saluki Association) will be offering the Brahma II Cup and the ASA Atlantic South East (ASE) Regional trophy for Salukis only. In order to claim the trophies, the winning Saluki must be owned by an ASA member in good standing. The highest scoring ASA-member-owned Saluki in the Open Stake(s), Field Champion Stake(s) and Veteran Stake(s) are eligible to run off for the ASA trophies. The website for the ASA is:

[americansalukiassociation.com](http://americansalukiassociation.com). There are also ASA medallions for the winners, one to go with each trophy. There are special ASA provided Saluki BOB ribbons for both days. There are also special ASA placement ribbons for Saturday ONLY for the Brahma II Cup.

About the ASA Brahma II Cup: The oldest lure coursing trophy offered by the ASA, the Brahma II Cup is a sterling silver elliptical bowl with silver ornamentation that rests on a wooden base. First presented in 1973 by the Hounds of Srinagar, it honors Am. Can Ch. Srinagar Brahma of Urray, FCh, bred by Richard and Barbara Webster (Urray) of British Columbia. Not only was Brahma II accomplished on the lure, but his brother, Bedouin, was the first recipient of this coveted award. The earlier Brahma II Cup trials were always run at Santa Barbara, CA, but currently it is a roving trial held in the various regions of the ASA, awarded annually.

About the ASA Regional Lure Coursing Trophies: The ASA Regional Lure Coursing trophies are plaque-style trophies with bronze reliefs at the top that were commissioned by donations from the various ASA regions and created by Saluki breeder, judge, and noted sculptor Garry Newton. Any of these can be awarded annually, and must be awarded at a two-day ASFA field trial weekend put on by any ASFA club.
